

School Parking Regulations
Rules Regarding Student Driving and Parking

There are a limited number of student parking spaces. To park on school property, a student must be assigned a parking decal by the Campus Police. When all student parking spaces have been assigned, there will be no additional parking decals issued.

1. In order to receive a parking permit, the student must:

- a. Fill out an application for student parking and have the application signed by a parent or guardian.
- b. Completed applications will be reviewed by the Campus Police and upon approval, will be given a parking decal.
- c. Applications will be approved based on the following criteria:
 1. Seniors
 2. Juniors
 3. When all spaces are issued a waiting list will be generated.
 4. 10th graders will not be considered for permits.

3. Once a parking permit is issued, the driver must:

- a. Adhere to all school rules, municipal and state motor vehicle laws. Suspension of driving privileges, ticket and towing of vehicles or suspension from school may result when violations of these regulations occur.
- b. All automobiles parked on school grounds must be registered with the school and must display a current decal. If your decal falls off or can't be seen it will be considered not there. If you lose your decal, it will be your responsibility to secure another one from the Campus Police. There will be a \$5 charge for additional decals.
- c. All students must have a valid N.J. Driver's License to receive parking privileges and the vehicles they drive must have a current registration and carry the proper insurance.
- d. Student vehicles may be subject to search if there are reasonable grounds to believe that drugs, alcohol, stolen property, or other contraband might be present in the vehicle.
- e. Students may not go out to the parking lot or to their vehicles during school hours. If you must, see Campus Police or your Grade Level Principal before doing so. Anyone caught in the parking lot or leaving school without authorization will lose their parking privileges, and face suspension from school. This applies to passengers as well.
- f. If someone parks in your space, park in the un-numbered student spaces at the end of the 3rd row and report the problem to the Campus Police by 9AM. NEVER park in a teacher's, visitor's, resident's, reserved space or a "no parking" area.
- g. If you drive a different vehicle without a decal, notify the Campus Police by 9AM. If no one is in the Campus Police Office, leave a note on the door.
- h. Your 9th lateness will result in the loss of your parking privileges.
- i. A second violation of any rules listed will result in a disciplinary report.
- j. When inclement weather is expected, please ride the bus.

OWNERS/DRIVERS PARK AT YOUR OWN RISK!

A student's parking privilege will be revoked for the following:

- 1. Motor vehicle accident with a school bus.**
- 2. Single file exit until buses leave the lot at dismissal.**
- 3. Cutting into school bus line while buses are exiting at dismissal.**
- 4. Any drug or alcohol violation.**
- 5. Leaving school without permission, passengers included.**

**Cherry Hill Police will be reporting to the school and Campus Police about students' driving habits to and from school. Students receiving tickets because of these habits will have their parking privilege at the school suspended for a minimum of 2 weeks.*
